I further understand that collaborative efforts must include each author’s signature on this agreement, and if more than one author signs the agreement, the reference “**I**” throughout the agreement applies to each designee—jointly and severally.
4. I warrant the submitted work is **not** presently under option and/or has **not** been purchased by a third party.
5. Fees – All submissions must be postmarked not later than **1 February**. A standard submission fee of **\$10** USC must accompany the submission (not more than 3 poems). Multiple submissions (in excess of 3 but not more than 6 poems) are **\$15**. For all work arriving after the deadline an additional **\$5** late fee will be imposed.
6. I have retained **one** copy of the work and release The Writers Place of and from any and all liability for loss of, or damage to, the copy of work submitted hereunder.
7. I understand The Writers Place will not seek employment for me, nor will The Writers Place act in the capacity of an agent, manager, or representative in behalf of my work.
